MINUTES REVIEW AND APPROVAL

Minutes of the October 20, 2022 meeting were reviewed. Del Ruesch made a **motion** to approve the minutes as written. Mitzi Gray seconded the motion, which was approved by unanimous vote.

ZARMANI PROPERTY

The Trails Committee discussed the purchase of the Zarmani property located above 700 East. Mitzi Gray discussed adding Open Space Zoning and a conservation easement to the property to protect the property for public use. This item will be discussed with Cory Snyder, Community Development Director.

DISCUSS TRAILWORK PROJECT IDEAS FOR VOLUNTEERS

Jamison Pexton explained the Viewmont Mountain Bike Team is starting a new season, and each member is required to perform three hours of volunteer trail service each year. Mikael Remington also helps with the team, and Jamison will talk to him for suggestions on service projects on the trails.

Spencer Summerhays, City Council Liaison, explained with the Zarmani property should be included in the Trails Master Plan, and then become part of the General Plan. Cory Snyder, Community Development Director, should be invited to the next meeting to discuss what the Trails Committee needs to do for the City Council to approve the creation of the Trails Master Plan, and to have it added to the General Plan.

1 Spencer Summerhays suggested the creation of a liaison committee to work with the Forest
2 Service to connect the trails on Forest Service land to Centerville trails. Bountiful also wants to
3 coordinate trails from Centerville to Bountiful on the Bonneville Shoreline Trail. The Trails Master
4 Plan should also include urban trails.

6 **INFRASTRUCTURE BILL**

8 Jamison Pexton asked about the new Infrastructure Bill, and if Centerville will receive any
9 of this money. Spencer Summerhays reported a large amount of this money will be used for the
10 new water tank being installed at the top of Chase Lane. He suggested a Forest Service liaison
11 work with Bountiful City to find ways to integrate the Bonneville Shoreline Trail with Bountiful,
12 Farmington, and Centerville. Former Centerville Mayor, Paul Cutler, is the House Representative
13 for our area, and should be contacted for information on what is happening on the Infrastructure
14 Bill.

16 **LAND PARCELS ON HILLSIDE**

18 Mitzi Gray discussed small parcels of land on the hillside where it is not feasible to build.
19 She would like to see a plan to present options to the landowners where they could sell their
20 property for a charitable cause, or for a conservation sale. This item could be discussed with Lisa
21 Romney, City Attorney. Spencer Summerhays suggested establishing a relationship with the
22 landowners to let them know the purpose of the Trails Committee and their interest in open space.
