RESOLUTION NO. 2023-01

A RESOLUTION AMENDING THE FY 2023 BUDGET OF FUNDS AND ACCOUNTS FOR THE MUNICIPAL BUILDING AUTHORITY OF CENTERVILLE CITY

WHEREAS, in order to conform with the Utah Code and Accounting Procedures as outlined in the Uniform Accounting Manual, it is necessary to amend the Municipal Building Authority budget of funds and accounts for the Fiscal Year ending June 30, 2023, as more particularly provided herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MUNICIPAL BUILDING AUTHORITY OF CENTERVILLE CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Amendment. The FY 2023 Budget of Funds for the Municipal Building Authority of Centerville City is hereby amended as shown in **Exhibit A** attached and incorporated herein by reference.
