18 **MINUTES REVIEW AND APPROVAL**

20 Minutes of the November 7, 2024 meeting were reviewed. Brandon Frederico made a
21 **motion** to approve the minutes as written. Allen Phelps seconded the motion, which was passed
22 by unanimous vote (3-0).

24 **DISCUSS TRAILS MASTER PLAN**

26 Allen Phelps displayed a map of the existing and proposed trails in the mountains east of
27 Centerville, which the Trails Committee reviewed. The Trails Committee approved the proposed
28 trails, but would like to add the Bernard Cut-off Trail and Social Pathway Trail that goes up
29 Bernard Canyon. Mark Pearson has been working on the verbiage part of the Trails Master Plan
30 that will be implemented into the General Plan. After the map is approved, it will be implemented
31 into the General Plan.

33 Allen Phelps requested that all Trails Committee members review the map and bring their
34 comments to the next meeting on December 4th. The Trails Committee will meet again on
35 December 12th to work on finalizing the map, and then meet on December 19th to finalize the map
36 for the General Plan.

40 Mitzi Gray has the courtesy signs ready that were ordered for the Bernard Trail and the
41 trail by the Nash property. The signs also show major trail points and right-of-way areas for sharing
42 the trails. Mitzi will take the signs to Mikael Remington's house. The Viewmont Mountain Bike
43 Team will be asked to install the signs when the weather is agreeable. The Mountain Bike Team
44 was going to do maintenance work on the trails but the work was cancelled because of the snow.

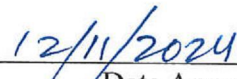

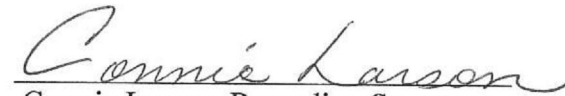
