18 **MINUTES REVIEW AND APPROVAL**

19
20 Minutes of the May 15, 2025 meeting were reviewed. Brandon Federico made a **motion** to
21 approve the minutes as written. Mikael Remington seconded the motion, which was passed by
22 unanimous vote (3-0).

24 **OUTDOOR RECREATION INITIATIVE GRANT**

25
26 Spencer Summerhays, City Council Liaison, reported on the Outdoor Recreation Initiative
27 that is a national model for the management of outdoor recreation. The Utah Division of Natural
28 Resources has an Outdoor Recreation Grant that is for new projects, new construction, upgrades,
29 and the acquisition of land easements. Mr. Summerhays has talked to staff regarding progress on
30 the General Plan, and staff is waiting to hear from the consultant. The next step is to have a work
31 session with the Trails Committee, Parks and Recreation Committee, and the city council to go
32 over the General Plan. The General Plan was delayed because the city council wanted more public
33 input. Brandon Federico will contact the mayor to see when he can present the Trails Master Plan
34 Proposal.

36 Brandon Federico said some of the proposed trails are on Forest Service property. There
37 are decisions that need to be made with the vacant property next to the Smith Park. This property
38 could be a pump track, splash pad, or new public safety office. The application for the Outdoor
39 Recreation Grant is due in two weeks, which is not enough time for the Trails Committee to apply
40 for it.

1 The General Plan must be approved and passed before the amenities can be planned for,
2 and then grants can be applied for. Spencer Summerhays said he has talked with Kay Harris from
3 Bountiful City on the Forest Service property that is between Bountiful and Centerville, but the
4 General Plan must be approved before anything can be done with the land.

6 **TRAILER/TOOLS**

8 Mikael Remington reported he had the money ready to purchase the trailer for the Trails
9 Committee, but the seller sold the trailer to someone else. Spencer Summerhays suggested the
10 Trails Committee make a list of items that are needed, and watch for grants as they become
11 available so they can be applied for. He suggested trying to form relationships with the mayor and
12 city council on items the Trails Committee would like to accomplish. Mr. Summerhays also
13 suggested sending emails to the mayor and city council, and go to the public comment session at
14 the city council meetings to inform them of what the Trails Committee is doing.
