23 **DEPARTMENT HEAD BUDGET PRESENTATIONS FY2021**

25 Bruce Cox, Parks and Recreation Director, provided an update on Parks and Recreation
26 Department personnel and vehicles, and presented the FY2021 Parks and Recreation Budget.
27 He explained that the baseball program raised \$8,000 in donations, and requests that the City
28 match the \$8,000 for installation of batting cages near the baseball fields at Community Park. Mr.
29 Cox presented the FY2021 Whitaker Museum Budget.

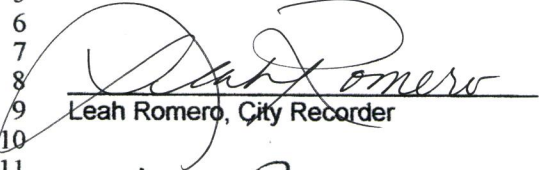

31 The Council and Staff discussed technology replacement and the possibility of putting
32 together a technology replacement schedule that would include all departments. Lisa Romney,
33 City Attorney, presented her FY2021 Department Budget.

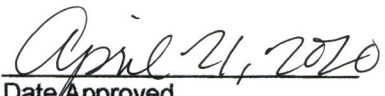

35 Cory Snyder, Community Development Director, presented the FY2021 Community
36 Development Budget, and talked about the need for a General Plan update, particularly the
37 transportation element. The Council and Staff discussed community outreach and third-party
38 professional involvement in the General Plan update process. Mr. Snyder estimated a General
39 Plan update would take 6-8 months. He expressed the opinion that the City would get a better,
40 more customized General Plan with a higher level of third-party professional involvement.
41 Councilmember Ince requested examples of different general plans. Mr. Snyder commented that
42 he was eligible for retirement in a few years, and suggested the Council keep succession planning
43 in mind.

45 Jake Smith, Administrative Services Director, presented FY2021 Budgets for the Court,
46 Administration, and Finance Departments. Brant Hanson, City Manager, talked about the
47 possibility of applying for federal grants.
